### **GREEN FEES** (all day; sales tax included)

Member players - \$15

### **RENTALS**

Clubs - \$10.00

### **TRAIL FEE FOR GOLF CARTS**

Non-member use of a personal cart on the course is prohibited, except during tournaments.

### **BASEMENT RENTAL**

Members only – Free (see policy)

Members - \$100.00

**PRO RATA DUES SCHEDULE** (when joining - see Bylaws)

The amount of dues is divided 12 and when the new member completes and submits the membership application the number of months is the amount due per month.

**PRO RATA DUES REFUND** (as provided in Bylaws)

This only applies to members that are in good standing, have been members for 1 year prior to the resignation and are in the following categories, regular, corporate, unmarried, and junior. Following the resignation the member may not use the club while a resident of Adair County. Additionally, the member must have moved out of Adair County, have serious illness, or have extenuating circumstances. The Board of Directors is the final authority for the refund and amount. The date of resignation is the date that the refund would be based upon.
